ORDINANCE NO. 2016-01

EMERGENCY SERVICES FEE ORDINANCE

The Board of Supervisors of the Town of Bellevue, ordains as follows:

Section 1: Definitions. The following terms used in this ordinance shall have the meanings stated:

- a. Contracted City: means a city or cities with whom Bellevue Township contracts to provide emergency or rescue services on an as-needed basis.
- b. Emergency Services: means services provided by the Contracted City deploying fire extinguishing equipment or personnel, emergency rescue equipment or personnel, or other similar services to any real or personal property located in the Township or provided to a resident or a visitor of Bellevue Township, including motorists passing through Bellevue Township.
- c. Reimbursement: means monies received by the Bellevue Township from either a resident or visitor of Bellevue Township, or the Minnesota Department of Transportation (MNDot) for Emergency Services rendered.

Section 2: Emergency Service Fees

- a. In the event Emergency Services from a Contracted City are provided to a property, a resident or a visitor in Bellevue Township, said property owner, person or persons shall pay Bellevue Township the amount that Bellevue Township is billed from the Contracted City as a direct result of the provision of such Emergency Services
- b. In the event a fire occurs in the right of way along a Minnesota state highway, MNDot shall reimburse the township pursuant to Minn. §161.465.
- c. Reimbursement of Emergency Service fees shall be paid within 30

days from the date the Township mails a bill to a user requesting or requiring said services.

Section 3. Collection Procedures.

Bellevue Township may employ all collection procedures authorized by law and as may be authorized by Minn. Stat. §§ 366.011 and 366.012 in collecting fees due under this ordinance. Any party who fails to pay Emergency Service fees when due shall be liable for all collection costs incurred by the Township.


Section 4. Effective Date.

This ordinance becomes effective immediately upon its passage and publication according to law.
